How We Use Your Information

Privacy Notice for Job Applicants

1. Introduction

Under data protection law, individuals have a right to be informed about how the school uses any personal data that we hold about them. We comply with this right by providing 'privacy notices' to individuals where we are processing their personal data.

This privacy notice explains how we collect, store and use personal data about individuals we employ, or otherwise engage, to work at our school.

We, Bradstow School, are the 'data controller' for the purposes of data protection law.

Successful candidates should refer to our privacy notice for school staff for information about how their personal data is collected, stored and used. This is available from the school's HR department.

If you have any questions/concerns about this notice please talk to the School Business Manager.

2. What is "personal data"?

Personal data is information that the School holds about you and which identifies you.

This includes information such as your date of birth and address as well as things like ethnicity and National insurance details. Any CCTV, photos and video recordings of you are also personal information.

3. The personal data we hold

We process data relating to those applying to work at our school. Personal data that we may collect, use, store and share (when appropriate) about you includes, but is not restricted to:

- Contact details
- Copies of right to work documentation
- References
- Evidence of qualifications
- Employment records, including work history, job titles, training records and professional memberships

We may also collect, store and use information about you that falls into "special categories" of more sensitive personal data. This includes information about (where applicable):

- Race, ethnicity, religious beliefs, sexual orientation and political opinions
- Disability and access requirements

4. Why we use this data

The purpose of processing this data is to aid the recruitment process by:

- Enabling us to establish relevant experience and qualifications
- Facilitating safe recruitment, as part of our safeguarding obligations towards pupils
- Enabling equalities monitoring

- Ensuring that appropriate access arrangements can be provided for candidates that require them

5. Our legal basis for using this data

We only collect and use personal information about you when the law allows us to. Most commonly, we use it where we need to:

- Comply with a legal obligation
- Carry out a task in the public interest

Less commonly, we may also use personal information about you where:

- You have given us consent to use it in a certain way
- We need to protect your vital interests (or someone else's interests)

Where you have provided us with consent to use your data, you may withdraw this consent at any time. We will make this clear when requesting your consent, and explain how you go about withdrawing consent if you wish to do so.

Some of the reasons listed above for collecting and using personal information about you overlap, and there may be several grounds which justify the school's use of your data.

6. Collecting this information

While the majority of information we collect from you is mandatory, there is some information that you can choose whether or not to provide to us.

Whenever we seek to collect information from you, we make it clear whether you must provide this information (and if so, what the possible consequences are of not complying), or whether you have a choice.

7. How we store this data

Personal data we collect is stored in line with our data protection policy.

We maintain a file to store personal information about all job applicants. The information contained in this file is kept secure and is only used for purposes directly relevant to your application for a job at the school.

Your data is also stored electronically on our SIMS.net computer database and within various folders on a secure server drive with password protected, limited access.

CCTV recordings of the outside areas are stored on digital video recorders which are situated in secured/locked locations.

Data Retention

When it is no longer required, we will delete your information in accordance with guidance from the Information and Records Management Society's toolkit for schools.

[This is currently not the case for your data kept on our SIMS database, but in the forthcoming summer 2018 update will enable us to delete your data records, as appropriate.]

Data security measures

Access to all this data is restricted by secure password and only accessible by a very limited number of staff, as appropriate to their job function.

On archiving your records these are stored off-site in a secure, locked container. Both these storage areas are locked and only accessible by a very limited number of staff, as appropriate to their role.

8. Data sharing

We do not share information about you with any third party without your consent unless the law and our policies allow us to do so.

Where it is legally required, or necessary (and it complies with data protection law), we may share personal information about you with:

- Our local authority – to meet our legal obligations to share certain information with it, such as shortlists of candidates for a head teacher position
- Suppliers and service providers – to enable them to provide the service we have contracted them for, such as HR and recruitment support
- Professional advisers and consultants
- Employment and recruitment agencies

Transferring data internationally

Where we transfer personal data to a country or territory outside the European Economic Area, we will do so in accordance with data protection law.

9. Your rights

How to access personal information we hold about you

Individuals have a right to make a **'subject access request (SAR)'** to gain access to personal information that the school holds about them.

If you make a subject access request, and if we do hold information about you, we will:

- Give you a description of it
- Tell you why we are holding and processing it, and how long we will keep it for
- Explain where we got it from, if not from you
- Tell you who it has been, or will be, shared with
- Let you know whether any automated decision-making is being applied to the data, and any consequences of this
- Give you a copy of the information in an intelligible form

You may also have the right for your personal information to be transmitted electronically to another organisation in certain circumstances.

If you would like to make a request, please contact the School Business Manager.

Your other rights regarding your data

Under data protection law, individuals have certain rights regarding how their personal data is used and kept safe. You have the right to:

- Object to the use of your personal data if it would cause, or is causing, damage or distress
- Prevent your data being used to send direct marketing
- Object to the use of your personal data for decisions being taken by automated means (by a computer or machine, rather than by a person)
- In certain circumstances, have inaccurate personal data corrected, deleted or destroyed, or restrict processing
- Claim compensation for damages caused by a breach of the data protection regulations

To exercise any of these rights, please contact the School Business Manager (see contact details below).

10. Complaints

We take any complaints about our collection and use of personal information very seriously.

If you think that our collection or use of personal information is unfair, misleading or inappropriate, or have any other concern about our data processing, please raise this with us in the first instance.
